Dreams Come True Codes of Practice - 1. Anyone under the age of 18 must not be involved in collecting sponsorship money. 2. Have two or more people present when collecting, counting and banking monies. 3. You should not carry out street collections which include; house to house or pub to pub collections on behalf of the Charity. Any collection of monies in a public place is governed under Charity Law. If an appropriate license is not obtained in advance, criminal prosecution may be the result. NB the Charity does not allow public collections. 4. All funds should be received by Dreams Come True Charity within 28 days of collection. Dreams Come True Charity will follow-up any non-received funds outside this time. 5. Under no circumstances must a bank account be opened in the name of Dreams Come True Charity. 6. If a bank account is necessary for your fundraising you must inform Dreams Come True Charity before making any arrangements.
